SUBJECT: Wage Stabilization Inspections
and BLS Wage Survey Programs

It has been agreed that our participation in the BLS program of collecting wage data is to continue. It is expected the work of collecting this data will taper off gradually, will vary from Region to Region, and will run through the month of September. Personnel presently working on this project are to continue on that detail until the release is given by the local BLS and WLB representatives, or this office.

Our participation in the BLS wage survey makes our NWLB program a three-way one:

1. The processing of applications and rulings,
2. The stabilization inspection work, and,
3. The wage survey.

If the demands on your WLB personnel are such that each of these three activities cannot be satisfactorily supported, you should notify this office with full explanations, sending a copy to Business Management. In this connection you may soon be called upon to furnish additional clerical personnel to this BLS wage survey project and in such cases, the foregoing should be taken into consideration.
