## "SHELTERED WORKSHOPS" ADVISORY COMMITTEE NAMED

Administrator Elmer F. Andrews, Wage and Hour Division, U. S. Department of Labor, today named an advisory committee of eleven members to discuss and report to him desirable additional regulations to govern employment of handicapped persons in charitable organizations and institutions.

The committee includes representatives of agencies for the care of handicapped persons employed in what are generally known as "sheltered workshops", and representatives of management and labor.

Mr. Andrews announced, in conjunction with the naming of the committee, a continuance until June 1, 1939 of the present temporary blanket exemption for "sheltered workshops" which was scheduled to expire April 1, 1939.

The Wage and Hour Division has been hampered by the smallness of its staff in the handling of applications for exemption of handicapped workers in institutions, from the 25-cent an hour minimum and these two extensions were necessary in order to obtain the advice of a group experienced in handling this and related problems.

The advisory committee has been directed to report as soon as possible on the following question:

"What, if any, additional regulations should be issued by the Administraor to provide for the employment, in sheltered workshops, of individuals whose earning capacity is impaired by age or physical or mental deficiency or injury, under special certificates issued by the Administrator, at wages lower than the minimum wage applicable under Section 6 of the Fair Labor Standards Act."

The term "sheltered workshops" includes only those charitable organizations and institutions conducted not for profit but for the purpose of carrying out a recognized program of rehabilitation for handicapped individuals and of providing such individuals with remunerative employment or other occupational rehabilitating activity of an educational or therapeutic nature.
