SHOE HEARING SCHEDULED THROUGH WEEK

A public hearing on the unanimous 35-cent-an-hour minimum wage recommendation of the Shoe Industry Committee under the Fair Labor Standards Act begins today before Major Robert N. Campbell, of the Public Contracts Board, as Trial Examiner for the Wage and Hour Division. The hearing is to be held at the Hotel Raleigh, Washington, D. C. and opens at 10 A. M.

Some 33 witnesses representing Government Agencies, trade associations, labor unions and individual shoe manufacturing firms have notified the Administrator of the Wage and Hour Division of their intention to appear and present testimony.

The 35-cent minimum wage was recommended by a committee of 27, equally representative of the public, the employees and the employers of the industry, and under the chairmanship of Msgr. Francis J. Haas, Dean of the School of Social Science, Catholic University of America. The recommendation is for the manufacture of all footwear from any material and for the manufacture of cut stock and findings. A wage study of this industry, largely a piece-work industry, made in the first part of this year indicated that some 60,000 wage earners of the 239,000 employed by the industry were earning less than the recommended minimum rate.

Today's sessions were to be devoted to the presentation of economic data by William P. Fallon and Frank Delgado, economists of the Wage and Hour Division; and by Dr. Jacob Perlman and Miss Faith Williams of the Bureau of Labor Statistics.
