## WOOD FURNITURE MANUFACTURING INDUSTRY COMMITTEE APPOINTED TO MEET JUNE 17

A committee will meet in Washington on June 17 to investiage economic and competitive conditions in the wood furniture manufacturing industry for the purpose of recommending a minimum wage, not in excess of 40 cents an hour, which will not substantially curtail employment in the industry, General Philip B. Fleming, Administrator of the Wage and Hour Division, U. S. Department of Labor, announced today. The meeting will begin at 10 a.m. in Conference Room B of the Interdepartmental Auditorium on Constitution Avenue between 12th and 14th Streets, Northwest, Washington, D. C.

In selecting the labor membership of this committee, the Administrator appointed an equal number of representatives from the American Federation of Labor and the Congress of Industrial Organziations.

It is estimated that there are approximately 142,000 employees in the industry, of which about 51,000 are receiving less than 40 cents an hour.

Persons whom the Committee or its representative considers substantially interested may appear at the hearing provided that not later than June 12 a notice of intention to appear is filed with Eurton E. Oppenheim, Director of the Industry Committee Branch, Wage and Hour Division, U. S. Department of Labor, Washington, D.C. This notice hust give the name and address of the person appearing, name and address of the person or persons he is representing, if any; a brief summary of the material to be presented, and the approximate length of time required.

The Wood Furniture Manufacturing Industry is defined as:

"The manufacturing, assembling, upholstering, and finishing, from wood, reed, rattan, willow, and fiber, of upholstered and other household, office, lawn, camp, porch, and juvenile and toy furniture, including but without limitation porcelain top breakfast furniture and radio, phonograph and sewing machine cases and cabinets the manufacturing and assembling, from wood, of furniture parts for the above, separately, set up or knocked down including but without limitation parlor furniture frames and chairs in the white.

"The manufacturing of any products covered under this definition shall be deemed to begin following the delivery of the wood from the kiln or from the air-dried dimension shed."

The recommendations for a minimum wage in the industry will cover all occupations necessary to the production of the articles specified in the definition, including cherical, maintenance, shipping and selling occupations; but does not include and employees of an independent wholesaler or employees of a manufacturer who are engaged exclusively in marketing and distributing products of the industry which have been purchased for resale.
